

IMPORTANT NOTICE

TO: ALL MPI REGISTERED ACCOUNT HOLDERS

We are pleased to announce that Manitoba Public Insurance, The Automotive Trades Association (ATA), and the Manitoba Motor Dealers Association (MMDA) have reached a two-year Labour Rate Agreement for accredited and non-accredited motor vehicle body shops in Manitoba. This Agreement provides rate increases for labour, paint materials and shop materials effective January 1, 2015 and to help attract and retain a skilled collision repair workforce in Manitoba, the successful Tool Allowance and Apprenticeship Grant program will continue to be funded.

As such Manitoba Public Insurance will honour the following rate schedule effective January 1, 2015. Beginning January 1, 2016, a further increase to body, paint, frame and glass only labour rates will be based on an inflation adjusted formula as follows: 40% of the Average Industrial Wage increase for Manitoba and 60% CPI increase for Manitoba based on the prior year.

The new rates will be honoured on all invoices where the Certificate of Repair has been signed by the insured on or after January 1, 2015.

The administration fee will continue to be paid on completed claims - where the vehicle is returned to the customer, with body, frame and/or mechanical labour. The administration fee will not be applied to glass-only claims.
