

Notice to All Commercial Repair Shops

Retro Pay Update and New Compensation Schedule for Qualified Commercial Repair Facilities

Date published: June 30, 2023

Manitoba Public Insurance will be updating the commercial labour and material rates as of July 1, 2023, in accordance with a new Industry Agreement. The following rates have been established:

Jul. 1, 2024 – Jun. 30, 2025	159.55	116.00	TBD*	TBD**	TBD**
Jul. 1, 2025 – Jun. 30, 2026	163.85	118.50	TBD*	TBD**	TBD**

* The shop material rate will be adjusted in accordance with the CPI calculation for Manitoba during the previous year.

** The paint material rates will be adjusted based on actual increases from the manufacturer.

Qualified Repair facilities will be receiving the following retroactive payments for eligible labour and material rates on payments invoiced, based on vendor type:

1. Claims invoiced between **January 1, 2022** and **June 6, 2023**, were processed earlier today. Due to the Banking Holiday for July 1, you may not see Electronic Funds Transfer (EFT) until July 4, depending on your financial institution.
2. Claims invoiced between **June 7, 2023** and **June 30, 2023**, will be paid in early July.

*For clarity, the term 'claims created' has been amended to 'claims invoiced' following the email you received on Monday, June 26, 2023.

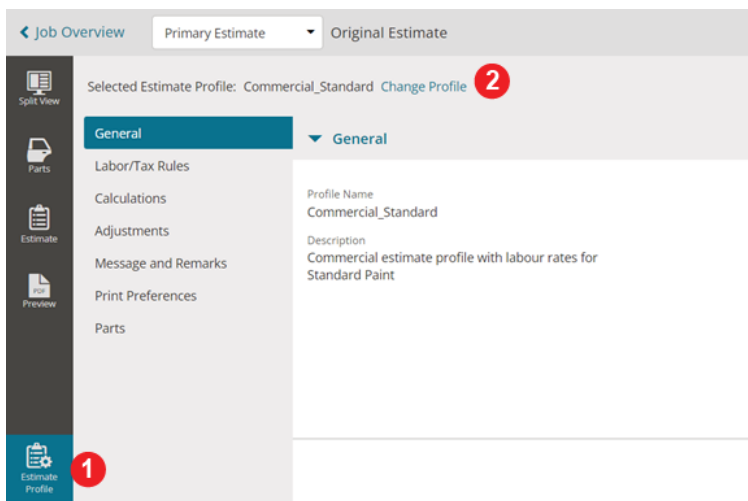
Eligible repair facilities and claims will be identified using invoice data. Each payment will also include both GST and PST. Estimates will not be updated to reflect these changes.

Commercial – Mitchell Cloud Estimating (MCE) and Ultramate

For claims created prior to July 1, 2023, it is the shop's responsibility to update the profile on each claim prior to submitting for payment.


To update the profile on an existing estimate in MCE:

1. Click **Estimate Profile** located on the left side menu bar.
2. Click **Change Profile**.



3. Select the applicable profile, which is indicated with “**(Updated)**” in the profile name:

4. Click **Apply**, then **Apply Changes**.

Estimate **Labour and Materials** will now be calculated with the updated rates.

Note: Updating the rate will create a supplement when the estimate is committed.
