Updates to Prior Action Items

System Enhancements

Glass Authorization form in MCG

- Auto populate two (2) fields Summer 2023
- Removing two (2) fields Fall 2023
- MPI is working on an offline version of the Glass Authorization to be used in situations when:
 - Systems are not working
 - Shops are not able to get all the invoice lines in MCG before the customer picks up the vehicle

Labour Rate Increases

- NTT will be published including implementation instructions and retropayment information
- MCG system enhancement will come into effect May 1, 2023
 - Any claim opened on or after May 1, 2023, will have the updated rate
 - If a claim is opened prior to May 1, 2023, but does not have any parts on the claim, the rates will be automatically updated
 - If a claim has a part on it at the time of May 1, 2023, the rates won't be updated but the labour rate increase will be provided in the retro payment for April and May payments. Starting June 1, 2023, if there is a claim without the updated rate, email GAU to updated before submitting for payment.



- Clarified that the updated labour rate for windshield claims is \$63.21 + \$4.00 (shop material) = \$67.21 and the rate in MCG will be \$67.21.
- No paper claims should be updated until May 1, 2023, all the ones submitted in April will be updated via retro payment

EV Claims Reporting

• MPI is currently working on providing claim counts by vehicle make. This information will be posted on the MPI Partners website with the other Glass Only Claim counts - <u>MPI Partners | Glass Only Claims</u>

Discussion Topics

- 1. ADAS Calibration Industry Collaborative Research
 - Industry asked that MPI look at the calibration process and compensation and make this a high priority item due to the increase of frequency it is occurring on claims
 - MPI has added the item to the list to look at this year and would like to attend a few facilities to witness a calibration with different tools
 - Industry recommends breaking down ADAS into different parts, but this could be difficult as all the pieces such as process, compensation, and supporting documentation are all tied together
 - MPI will be reviewing the ADAS calibration estimating standard and will adjust as needed to ensure shops understand the standard and the allowances are per component that require calibration
 - The shop will need to support their ask to be paid for multiple components to be calibrated with OEM procedures

2. Trade-in Authorization

- Went back and for with the legal and claims departments to ensure the form could be used for both PD and glass claims
- This form does not replace the glass authorization but will be used to allow the new owner of a vehicle to get the vehicle repaired under the prior owners claim number
- Requested to add a field for the license plate number
- There will be an NTT sent when the final version is ready and posted to MPI Partners
- MPI is hoping to have this completed for the end of April

3. Process Improvements

- Discussion Any items that we should look at?
- Having manual glass claims in MCG instead of filling out the paper copies
 - MPI is in the process of reviewing this with Mitchell along with reviewing MPI internal processes that could change to accommodate more claims going through MCG instead of a manual glass claim

- Hardware lines in MCG should not have a price listed and should be \$0 as the pricing is based on cost +25% markup
- Request to look at providing shops with access to add excessive clean up to claims and adding a supporting photo to be reviewed post payment

4. Clean Up of Glass Standards

- The glass standards have been reviewed by MPI for opportunities to clarify and provide more context based on conversations the Glass Audit Unit has with shops. A summary of the changes has been emailed to the glass committee members to be reviewed
- A draft will be posted for 30 days, and any recommendations can be emailed to Robert and Sandra
