

## **MPI Windshield Damage Evaluator Tool – Guidance for Glass Shops**

To support consistent documentation and decision-making for windshield repairs and replacements, Manitoba Public Insurance (MPI) has introduced a transparent windshield damage evaluator tool.

## **Purpose of the Evaluator Tool**

Designed to be placed over windshield damage when taking photos. Helps guide repair decisions and supports documentation. Ensures photos are clearly associated with the correct claim by including the claim number and license plate.

## **Usage Requirements**

The evaluator must be used when submitting photos of windshield damage. It provides visual context and scale, supporting repair vs. replace decisions. Photos must clearly show the evaluator, damage, claim number, and plate.
