



Notice to All Accredited Autobody and Glass Shops

2021 Light Vehicle Repair Industry Agreement Compensation Update – Effective June 14, 2024

Date published: June 7, 2024

In accordance with the [2021 Light Vehicle Repair Industry Agreement Compensation Schedule](#) and following discussions with the consultation committees, MPI will be making system changes effective June 14, 2024 to update the applicable rates.

Glass only Claims – MCG

The rate updates will be applied automatically to all new and existing claims in MCG.

Materials

Material rates will receive the scheduled increase plus an additional unscheduled increase that MPI determined was required. Both the schedule and total including unscheduled can be viewed in the table below:

Foams & Adhesives

The foam & adhesive kit allowances have also been reviewed and MPI determined an additional increase was warranted. The new values are listed in the table below. Small and large foam or adhesive kit line items must be removed and re-added on all in progress estimates to reflect the new rates.

Mechanical Specialty

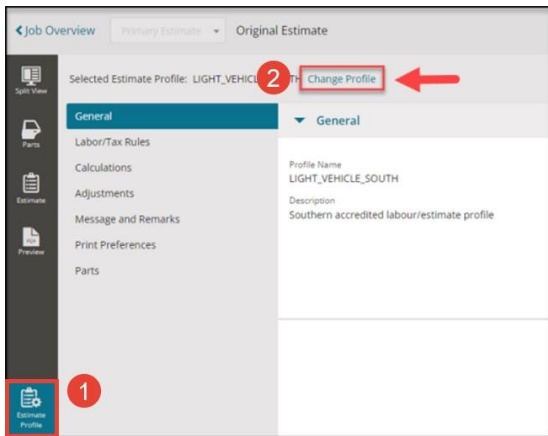
The Mechanical Specialty line entry value has been adjusted to ensure an accurate calculation with the scheduled rate changes. Mechanical specialty line items must be removed and re-added on all in-progress estimates to reflect the correct rates.

Physical Damage - MCE

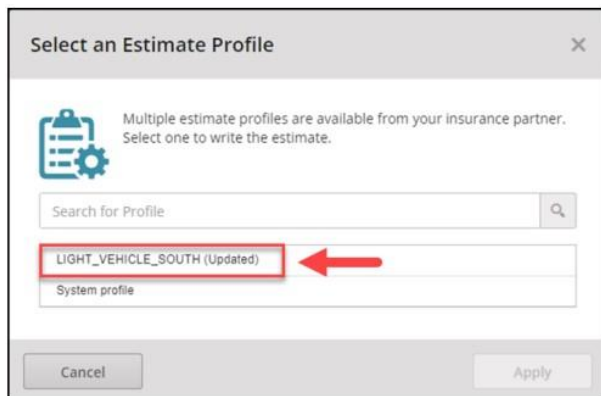
For pre-existing claims submitted for payment on or after June 14, 2024, it is the shop's responsibility to update the profile on each claim prior to submitting for payment. Shops are not to manually modify MPI profiles.

To update the profile on an existing estimate in MCE:

1. Select **Estimate Profile** from the left side menu bar.
2. Select **Change Profile**.



3. Choose the applicable profile, which is indicated with “**(Updated)**” in the profile name:



4. Select **Apply**, then **Apply Changes**.

Estimate **Labour** and **Materials** will now be calculated with the updated rates.
