Towing Related Costs

Invoice Requirements

The following documentation is required to support all towing and/or storage related invoices when submitting a request for payment.

- Claim number and/or stock number when available;
- Vehicle information including:
 - Plate Number;
 - VIN;
 - Year;
 - Make;
 - Model; and
- Tow completed date(s);
- Vehicle received at Storage Yard and Claim Vehicle exited Storage Yard dates; and
- Clear photos and other supporting documentation as required.

Invoices Submitted within 90 Days

All invoices related to towing and/or storage shall be submitted no later than 90 days after:

- The final tow completed date or;
- The date the vehicle left the compound; whichever is deemed latest.

Any invoices submitted to MPI after 90 days may not be considered for compensation.

Towing Related Costs Vehicle Descriptions

Towing related costs will apply to all Light Duty and Medium Duty Vehicles.

Light Duty Vehicle

Claim Vehicles with a gross vehicle weight rating (“**GVWR**”) of 4,500 kilograms or less.

This category includes, but is not limited to:

- Passenger cars;
- Vans / Minivans;
- SUVS;
- Motorcycles;
- ORVs; and
- Pickup trucks (Quarter ton and half ton).

Medium Duty Vehicle

Claim Vehicles with a GVWR greater than 4,500 kilograms up to and including 9,000 kilograms. This category includes, but is not limited to:

- Fifth wheels;
- Cube vans;
- Small buses;
- RVs and motorhomes;
- Ambulances;
- Small dump trucks;
- Box trucks;
- Delivery vans;
- Pickup trucks such as:
 - GM and Dodge 2500 / 3500; and
 - Ford F250 / F350 / F450 / F Series Super Duty; and
- 2500-series diesel trucks.

This fee is inclusive and replaces any daily storage charges that may otherwise be billed in conjunction with the indoor storage.</p> <p>The flat fee also includes towing the Claim Vehicle into and out of the building for the investigation.</p> <p>To qualify for this fee, you must provide:</p> <ul style="list-style-type: none">Written and signed documentation from the requesting law enforcement agency confirming the indoor storage requirement, including the name and badge number of the requesting personnel; andSpecific dates the Claim Vehicle was stored indoors.
Damage Mitigation Materials	\$5.00 / opening		<p>When keys are present, you must attempt to roll up or close windows and openings. However, if damage prevents securing the opening, materials such as plastic wrap may be used to mitigate further damage and are billable per opening, with supporting photos and justification required.</p>

Unloaded Mileage

“**Unloaded mileage**” means the distance traveled from your place of business (or the nearest practical location) to the pick-up site prior to loading the Claim Vehicle. Mileage after attending the pick-up location (e.g., return to your facility) is not billable as Unloaded Mileage. The Unloaded Mileage rate shall be equal to the loaded mileage rate. You may bill unloaded kilometers only for Sublet Tows, Direct Tows, or situations where customers alter the original tow arrangements. Invoices must include:

- (a) Starting point and destination for Unloaded Mileage;
- (b) Total kilometers traveled; and
- (c) Clear indication that the tow qualifies as a Sublet Tow or Direct Tow.

Sublet Fee

When you hire a third-party service provider to complete a claim towing operation, such as the use of a tractor, skid steer, picker truck, or equivalent equipment, MPI will allow a sublet fee of 20% of the third-party invoice, up to a maximum of \$1,000.00 per sublet invoice. Billing conditions include:

- (a) The sublet fee applies only to recovery-related services that you are unable to perform directly;
- (b) A copy of the third-party invoice must be submitted with your billing; and
- (c) Scene photos and a written justification may be requested to support the necessity of the sublet.

MPI reserves the right to review and approve sublet charges on a case-by-case basis. Invoices submitted without proper documentation may be denied.

Pre-Approved Fees

Unless explicitly stated otherwise in this Agreement, MPI shall reimburse you for reasonable out-of-pocket expenses relating to the provision of the Services if:

- (a) such expenses were reasonably required for the performance of the Services;
- (b) prior written permission to incur such expenses was first obtained from MPI;
- (c) you use the most economical methods possible for the expenses;
- (d) you provide receipts, photos and/or supporting documents to the satisfaction of MPI, unless it is agreed that submission of receipts for certain categories of expenses is not required (for example, a per diem approach); and,
- (e) reimbursement to you for out-of-pocket expenses shall be in accordance with the amounts and guidelines set out in the MPI’s Corporate Directives.

MPI shall not be responsible for payment of any other expenses you incur in the performance of this Agreement.
