

## Light Vehicle Towing and Storage Master Service Agreement Rate Card Effective September 1, 2022

## 1.0 <u>Towing Fees</u>:

Upon signing this agreement, Manitoba Public Insurance will pay you the following fees for the following Services related to Light Vehicle Tows:

Service	Amount		Description

Basic Tow	\$73.00	\$81.00	This basic tow rate includes hook up and attaching vehicle to tow truck. This rate is set for all on-road types or weather conditions.
Winching & Recovery (per hour)	\$65.00	\$83.00	When deemed required to provide access for hooking up a vehicle. Please charge by the half hour.
Kilometre Charge	\$ 2.75	\$ 3.70	Per kilometre travelled while towing claim vehicle. Vendors can bill for unloaded kilometres for Sublet Tows and Direct Tows.
Dolly / Deck Charge	\$30.00	\$30.00	Dollies or a deck can be used in circumstances that may include flat tires or damaged wheels. Pictures should be included in circumstances where dollies are used and not specified by the manufacturer as a requirement. Use of jack included.
Extra Labour (per person, per hour)	\$30.00	\$30.00	This is for additional labour that is necessary to complete the task/procedure (does not include ride-alongs or the tow truck operator). Please charge by the half hour.
Storage: Rural Fenced or Compound	\$ 7.00	\$ 7.00	Per day.
Storage: Rural Open Lot	\$ 4.00	\$ 4.00	Per day.
Oversized Storage: Fenced	\$15.00	\$15.00	Applicable for vehicles that take up the amount of space equal or greater than two (2) average size light vehicles.
Site Cleanup (per person, per hour)	\$30.00	\$30.00	When additional clean up requiring more than 15 minutes is needed, please charge by the half hour. Pictures must be included, and any products used/disposed must be added separately from this charge.
Marketing Photo Fee	\$25.00	\$25.00	Upon request by MPI, take pictures of a total loss unit at a storage facility, used for auction purposes.



North: Thompson, Flin Flon, The Pas, Leaf Rapids, Lynn Lake, Churchill, Gillam, Norway House.

**South**: Arborg, Beausejour, Brandon, Dauphin, Selkirk, Portage, Steinbach, Swan River, Winkler, Winnipeg. **Light Vehicle Towing Rates** apply to vehicles less than 4540 kg and camper trailers measuring less than 35 feet

\*Rates will be reviewed every three (3) years.

## 2.00 Pre-Approved Fees

Unless explicitly stated otherwise in this Agreement, MPI shall reimburse the Vendor for reasonable out-of-pocket expenses relating to the provision of the Services if:

- (a) such expenses were reasonably required for the performance of the Services;
- (b) prior written permission to incur such expenses was first obtained from MPI;
- (c) the Vendor uses the most economical methods possible for the expenses;
- (d) the Vendor provides receipts, photos and/or supporting documents to the satisfaction of MPI, unless it is agreed that submission of receipts for certain categories of expenses is not required (for example. a per diem approach); and,
- (e) reimbursement to the Vendor for out-of-pocket expenses shall be in accordance with the amounts and guidelines set out in the MPI's Corporate Directives.

MPI shall not be responsible for payment of any other expenses incurred by the Vendor in the performance of this Agreement.
