

New Rental Vehicle Agreement and Loss of Use Rates

Manitoba Public Insurance has developed a [new agreement](#) to be used directly with rental car companies in collaboration with the Manitoba Car and Truck Rental Association (MCTRA). The new agreement came into effect on **April 1, 2022**.

The new agreement contains a streamlined rental vehicle rate and compensation structure that becomes effective **July 1, 2022**. The daily rate for **Basic LOU** and **Extension LOU Level 1** will increase to \$42.00, plus tax. Customers will no longer be able to purchase **Extension LOU Level 2**. However, if they purchased this policy prior to July 1, 2022, their coverage will remain in place for the duration of their policy. The product names will also change. See the table below for the new rates and product names.

If we do not receive your signed agreement by August 15, 2022, your account will be removed from the web application and as a result you will be required to manually bill MPI for rental invoices.
