Vehicle Equipment, Safety and Inspection (VESI) Regulation Coming March 1

Overview

VESI comes into force with the proclamation of The Traffic and Transportation Modernization Act (TTMA) on March 1, 2019.

As presented by MPI in the recent series of information sessions, below is important information and resources about VESI.

NOTE: VESI applies to light vehicle and motorcycle inspections only. It does **not** apply to the Periodic Mandatory Vehicle Inspection (PMVI) program.

New Light Vehicle COI Form

Please discontinue using old COI forms on February 28, 2019.

- To receive a credit, return unused old forms to an MPI Service Centre, or directly to Vehicle Safety.
- Stations are required to keep green copies from a partial book of old certificates for two years.

The new COI form is **now available** and is effective **March 1, 2019**. Purchase new forms at an MPI Service Centre or from Vehicle Safety.

• **Note**: The Recall information at the bottom of the COI form is considered advisory information for the customer only. It is not an inspection requirement.

Additional Items to Remember

- Station Email Accuracy Vehicle Safety will communicate with you through email, so please
 ensure we have your correct email address. Contact Vehicle Safety if you need to change your
 station email address.
- Window Tint Meters Window tint meters are now mandatory equipment for conducting an inspection. The tint meter should be self-calibrating, and able to do fixed glass. Smartphone calibration applications will not be acceptable until proper testing is completed.
- **Light Vehicle Information Package** The Light Vehicle Information Package is being updated and will be posted to MPI Partners when completed.
- Light Vehicle and Motorcycle Certified Stations Stations certified in both Light Vehicle and Motorcycle inspections are not required to attend both sessions. Instead, please review the Motorcycle Inspection Presentation in MPI Partners.
