

Background

Labour rates for RV, ORV, & Motorcycles may be applied as follows. Refer to the rules and procedures below for correct application to the estimate or [Amendment Form](#).

Rules

1. Recreational Vehicle, Motorcycle, and Off-Road Vehicle rates are as follows:

Vehicle Type	Effective Date	Labour Operation	Rate
Recreational Vehicle	September 9, 2019	Body	\$90.00 / hr
		Mechanical	\$90.00 / hr
Off-Road Vehicle	March 1, 2018	Body	\$90.00 / hr

Motorcycle	March 1, 2018	Body	\$90.00 / hr
		Mechanical	\$90.00 / hr

Remediation allowances are paid at the light vehicle body rate which is listed in the [Light Vehicle Repair Industry Agreement Compensation Schedule](#), these operations are not eligible for the rates listed above.

2. To be eligible for the light vehicle accredited [refinish rate](#), MPI-recognized RV, ORV, and Motorcycle repair facilities must provide a sublet invoice from a light vehicle accredited repair shop.

The rates above are the maximum allowed; however, repair facilities may choose to charge lower rates.

Examples

A MPI recognized motorcycle repair shop has finished an amendment on a customer's motorcycle. Once they have totaled all the repair hours, they apply the Motorcycle/ORV rate and add it to the amendment form. They then double check all calculations and submit the supplement to MPI for approval.

Parts Autonomy Privileges

RV, ORV, & Motorcycle claims are excluded from the Parts Autonomy program.

Best Practices

To avoid multiple calculations, ensure all supplemental repair operations have been identified prior to calculating the increase labour rate.

Procedure


Mitchell Cloud Estimating

Follow this procedure to enter RV labour rates on an estimate in MCE.

The information listed in the following procedures are for demonstration purposes only, refer to the rules above for current labour rates.

Begin with the estimate open in Mitchell Cloud Estimating.

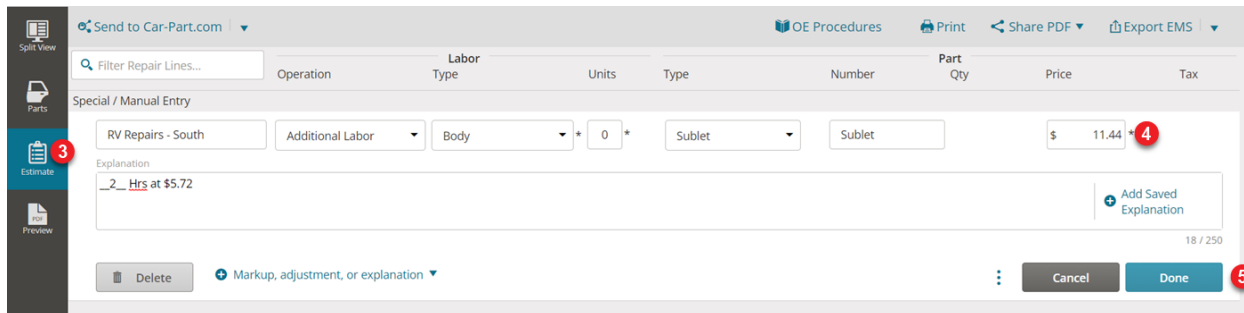
1. Select the **RV Labour Rates** folder in **My Templates**.
2. Select the applicable labour rate and click **Add Line**.

3. From the **Estimate** tab, select the applicable line item and enter the total number of eligible RV labour hours into the calculation in the **Explanation** line provided.
4. Enter the calculated labour amount (total number of eligible labour hours multiplied by the difference between the accredited body labour rate and the RV rate) into the **Price** field.
5. Click **Done**



Virtual Claim Files Process

Follow the steps below to request motorcycle or ORV labour rates on an estimate using the [Estimate Amendment form](#).

1. Complete and submit an Estimate Amendment as follows when submitting the Final Repair Account (FRA).

Requests for the Motorcycle/ORV rates should only be submitted with the FRA, not on each supplement. This will be factored into the repair costs on your FRA.

- In the **Line Description** field, enter “**Motorcycle/ORV Rate**”.
- In the **Reason for Change** field, enter the number of labour hours and the applicable rate*. For example, “4 hrs @ \$13.00”.

*For body and mechanical repairs, enter the difference between the Motorcycle/ORV labour rate (\$90) and the current accredited rate for each region. For example:

- South = \$13.00 (\$90 - \$77.00)

- In the **Parts Cost** field, enter the calculated total. For example, 4 x \$13.00 = “\$52.00”
